2. **George² BURRILL** (*not known¹*) was born circa 1555 in Boston, Lincolnshire, England and died there in 1588; he was 33. George was buried on 25 September 1588 in Boston, Lincolnshire, England^[1,2]. His will was proved in 1588 and can be found at the Consistory Court of Lincoln, at Lincoln^[3].

On 23 June 1577 when George was 22, he married **Alyce BENYSON**, in Boston, Lincolnshire, England^[1,2]. Their marriage entry reads "George Burrell and Alyce Foxe". Alyce died in 1596 in Boston, Lincolnshire, England and was buried there on 9 August 1596. Variations on her first name include Alyce, Agnes, Annys, and the like.

5. William BURRILL (*George², not known¹*) was born circa on 2 April 1578 in Boston, Lincolnshire, England as "William Borrell son of George"^[1,4] and died in Boston, Lincolnshire, England in 1588; he was 9. He was buried there on 6 September 1588^[1,2].

6. Elizabeth BURRILL (*George², not known¹*) was born on 19 January 1580/1 in Boston¹, Lincolnshire, England as "Elizabeth daughter of George Burrell"^[1,4] and died in Boston, Lincolnshire, England in 1584; she was 3. She was buried there on 17 November 1584^[1,2].

7. Robert BURRILL (*George², not known¹*) was born on 2 September 1583 in Boston, Lincolnshire, England as "Robert son of George Borrell"^[1,4] and died in Boston, Lincolnshire, England 30 in 1589; he was 5. He was buried there on 30 September 1589^[1,2].

8. Jane BURRILL (*George², not known¹*) was born on 31 October 1584 in Boston, Lincolnshire, England as "Jane daughter of George Burwell"^[1,4]. On 22 May 1608 when Jane was 23, she married **Charles THORNTON**, a carpenter, in Boston, Lincolnshire, England^[1,2].

9. Johanna BURRILL (*George², not known¹*) was born on 1 July 1587 in Boston, Lincolnshire, England as "Johanna daughter of George Burwell"^[1,4] and died in 1588 in Boston, Lincolnshire, England. She was buried there on 12 October 1588^[1,2].

10. George³ BURRILL (*George², not known¹*) was born on 13 March 1588/9 in Boston, Lincolnshire, England -- after the death of his father -- as "George son of George Burwell"^[1,4] and died in Lynn, Essex co., MA in 1653; he was 64^[5]. His death record reads "Burrill, George, b. England" and only the year of his death is given. George died between between 18 October 1653, when he wrote his will, and 21 June 1654, when inventory was taken on his estate.

Family history relates that they came over with the "Winthrop Fleet" in 1630. However, there is absolutely no proof of when or on which ship George & family migrated. The earliest authentic record of George Burrill in New England is as a defendant in a civil case at the Salem Court on 28 March 1637^[4,6]. It is more likely that the Burrills migrated with the great swell of The Great Migration in 1635 or so. I estimate this date because he was well established enough (and enough of a contributing founding member to the town of Lynn, Essex co., MA) to receive 200 acres on the western side of Willis' Hill in the 1638 Lynn land grant. His home was on the south side of Boston Street on the westerly slope of Tower Hill^[3]. Like so many, America made George Burrill. He was a simple cooper when in England, but in Lynn, he became one of the wealthiest planters in the area and when he died, his estate was appraised at £848. 10s. However, when one examines his estate inventory, it is clear that he also was a cooper here in New England. As seen by the fact that George signed his will and owned books at the time of his death, he was an educated man and clearly passed this along to his children. Thus, the family became one of the most honored in the Lynn, Essex co., MA area.

George's will was dated 18 October 1653 and estate inventory was taken on 21 June 1654. His will and inventory are one of the most extensive I've come across in family research. I've added line and paragraph breaks for ease of reading:

"The wille of George burrill senior || yt after my deathe || my house wherein I dwell I Giue to my sonn frances with all the land and meadow lying near adioyoning to it with all farms outhouses &c: and || ye || barn I giu to him yt is neare to ye land of Thomas Chadwell, || Land || formerly william Edward with all the vpland and meadow adioyning vnto it and belonging thevnto This I giue vnto him & his heirs yt is lawfully begotten of his body for ever I giue vnto my sonn John that house wch. formerly was ffrancis his with all the land belonging vnto it and yt pece of land neat Rich moors and alsoe I giu him fourteen acrs of salt

Laughton with my sonn ffrancis should see this my will fulfilled alsoe my will is that mr whiting and mr cobbett shall haue fourty shillings a peece out of my estate and Tho. Laughton twenty shillings all to be paid within one half yeare after my death. Dated 18th october 1653."

On 12 January 1626/7 when George was 37, he second married **Mary COOPER**, daughter of **Timothy COOPER & Elizabeth [surname not known]**, in Boston, Lincolnshire, England^[8,9,12,13,14,15,16]. A marriage license was granted on 12 January 1626/7 in Lincolnshire to George Burrell of Boston, æ 35, and Mary Cooper of Appley, spinster, æ 20. The application for the license was made by John Creswell of Kingthorpe in Appley, yeoman. (*Lincolnshire Marriage Licenses*)^[4] Mary was born circa 1606 -- possibly in Appley, England -- and died in Lynn, Essex co., MA on __d:6m(August):1653; she was 47^[17]. Her death record can be found in the Lynn, Essex co., MA vital records under "Burel, Mary, w. George".

11. William BURRILL (*George*³⁻², *not known*¹) was born on 19 April 1618 in Boston, Lincolnshire, England as "William son of George Borrell, cooper"^[1,4] and died in 1618 in Boston, Lincolnshire, England. He was buried there on 24 May 1618.

12. Marie BURRILL (*George³⁻², not known¹*) was born on 6 June 1619 in Boston, Lincolnshire, England as “Marie daughter of George Borrill, cowper”^[1,4].

13. George BURRILL (*George³⁻², not known¹*) was born on 15 July 1621 in Boston, Lincolnshire, England^[1,4,18]. His birth is listed in the Lynn, Essex co., MA vital records as “Burrill, George, s. George [bef. 1640]”. His birth is also recorded in the Parish Register as “George son of George Burrell”. He died in Boston, Suffolk co., MA on 5 July 1698; he was 76^[19].

Like his namesake father, George was a cooper and apparently inherited the house in Boston, as he is listed as being “of Boston, MA”^[19]. His will was dated 4 October 1693 and proved 14 July 1698^[19]. George married **Deborah SIMPKINS**, daughter of **Nicholas SIMPKINS & Isabel [surname not known]**.

14. Sara1 BURRILL (*George³⁻², not known¹*) was born on 19 September 1622 in Boston, Lincolnshire, England as “Sara daughter of George Burrill”^[1,2] and died in 1622/3 in Boston, Lincolnshire, England. She was buried there on 19 January 1622/3^[1,2].

15. Sara2 BURRILL (*George³⁻², not known¹*) was born on 15 February 1623/4 in Boston, Lincolnshire, England as “Sara daughter of George Burrill”^[1,2] and died there 1629; she was 5. She was buried on 30 April 1629 in Boston, Lincolnshire, England^[1,2].

16. John1 BURRILL (*George³⁻², not known¹*) was born on 15 January 1625/6 in Boston, Lincolnshire, England as “John son of George Burrill”^[1,2] and died in 1625/1626 in Boston, Lincolnshire, England. He was buried there on 21 January 1625/6.

17. Francis BURRILL (*George³⁻², not known¹*) was born on 30 (20) January 1627/8 in Boston, Lincolnshire, England^[1,2,18]. His birth is in the Boston, Lincolnshire, England Parish Register as “Frauncis son of George Burrill”. His birth is also in the Lynn, Essex co., MA vital records under “Burrill, Francis, s. George [before 1640]”. Francis died in Lynn, Essex co., MA on 10 November 1704; he was 77^[20]. Francis lived in Lynn, Essex co., MA all his life.

Before 18 October 1653 when Francis was 26, he married **Elizabeth [surname not known]**, in Lynn, Essex co., MA^[8,12,13,21,22,23]. Elizabeth was born circa 1634 -- her birth year is estimated from her death record in the Lynn, Essex co., MA vital records. She died in Lynn, Essex co., MA on 22 April 1716; she was 82^[24].

18. Martha BURRILL (*George³⁻², not known¹*) was born on 14 February 1629/30 in Boston, Lincolnshire, England as Martha daughter of George Burrell^[1,2] and died there in 1632; she was 2. She was buried on 30 November 1632 in Boston, Lincolnshire, England^[1,2].

19. Lieutenant John² BURRILL (*George³⁻², not known¹*) was born on 16 August 1632 in Boston, Lincolnshire, England^[1,2,18]. His birth is recorded in the Boston, Lincolnshire, England Parish Register as "John son of George Burrell". Like his brother, Francis, his birth is also recorded in the Lynn, Essex co., MA vital records as "Burrill, John, s. George [bef. 1640]". John² died in Lynn, Essex co., MA on 24 April 1703; he was 70^[5]. Note that the Lynn death record says that he was "a. 72 y."

He was a maltster and tanner. As discussed in the record of Thomas Newhall (1630), the town maltster was an important occupation of some skill. Since the English emigrants brought with them their intense mistrust of well water, the Great Migrants drank mostly beer, cider and -- in summertime, when it was plentiful -- milk. While any housewife could make terrific beer and cider, the task of converting grain to malt (a necessary ingredient for beer) was best left to a professional. Chances are, John² worked with and/or apprenticed with Thomas Newhall.

As seen by his title, he also was in the Lynn militia and was popular enough to have been elected a junior officer by his men. John served as Representative to the Massachusetts General Court for the town of Lynn in 1691, 1692 and 1697. He also served as Town Clerk in 1691^[25].

On 10 May 1656 when John² was 23, he married **Lois IVORY**, daughter of **William IVORY & Ann SOUTH**, in Lynn, Essex co., MA^[8,26,27,28,29,30,31,32,33,34,35].

35. Captain John2 BURRILL Esq. (*John⁴, George³⁻², not known¹*) was born on 7 January 1663 in Lynn, Essex co., MA as "Burrill, Jo[h]n, s. Jo[h]n"^[44] and died in Lynn, Essex co., MA on 10 December 1721; he was 58^[20]. John, Jr. took the Oath of Freeman on 18 April 1691^[45]. Like his father, John2 served in the militia and made the senior rank of Captain. Also, like his father, he served as Representative to the General Court for the Town of Lynn in 1691, 1692, 1693-1696, 1698-1701, 1704, 1707, 1709 and 1711-1719. In 1707 and 1709, he was elected Speaker of the House^[25]. On 28 July 1680 when John2 was 17, he married **Mary STOWERS**, daughter of **Richard STOWERS** and **Hannah FROST** in Lynn, Essex co., MA^[46].

On 13 October 1702 when Ebenezer was 23, he married **Martha FARRINGTON**, daughter of **Mathew FARRINGTON Jr. & Sarah POTTER**, in Lynn, Essex co., MA^[52].
