Surname variations include: Farrington, Farington, Farrinton, Farinton, Fareington & ffarrington [sic].

## First Generation

---

**1. Edmund<sup>1</sup> FARRINGTON** was born circa 1588 in Olney, Buckinghamshire, England<sup>[1,2]</sup>. His birth year is estimated from the fact that he was aged 47 when he migrated in 1635. Edmund died in Lynn, Essex co., MA as "Farrington, Edmond on 20d:11m(January):1670; he was 82<sup>[2,3,4]</sup>.<sup>2,3,4</sup>.

Edmund; his wife, Elizabeth; and their children, Sarah, John, Elizabeth, Mathew & Martha migrated from England to America aboard the *Hopewell*; of London, William Bundocke, master, embarking 1-6 April 1635 and sailing from London, Middlesex, England on 6 April 1635 and arriving in Boston, Suffolk co., MA in June 1635<sup>[6]</sup>. Their children, Thomas, Edward and Joseph stayed in England. They are listed on the ship's manifest as "Edmond Farrington of Oney 47, his wife Elizabeth 49, and their children Sarra 14, Mathew 12, John 11, and Elizabeth 8"<sup>[21]</sup>. Edmond had taken the oath of Allegiance<sup>[1]</sup>. These records are currently located in Westminster Hall, London.

Edmond settled immediately in Lynn, Essex co., MA and became a Farmer, the Owner of the "well known tidemill in Lynn" and a Fellmonger<sup>[5,6]</sup>. A Fellmonger both prepared hides (especially sheep hides) by removing the hair from them and drying them and also one who was a dealer for hides & skins. Edmond was not educated and could only "sign by mark" to the Southampton documents<sup>[7]</sup> and his own will. His occupation as "Fellmonger" is substantiated by court documents of 1 December 1654, in which William Lyon, the son of John Lyon of Marblehead, said in court that he was apprenticed to "Edmond Farrinton of Lyn, fellmonger" for a period of eleven years<sup>[6,8]</sup>. He later also became the Corn Miller in Lynn, when he built the aforementioned tidemill.

He contributed greatly to the establishment of the new settlement of Lynn and was granted 200 acres of land in the 1638 Land Distribution of Lynn<sup>[23,25]</sup>. This was one of the larger land grants and indicated that Edmond had contributed a great deal of money to the town during its founding. His parcel was west of Myrtle and Federal Streets and he established his homestead partly on the western side of Federal Street and partly on the western side of Myrtle Street in an area known as "Farrington's Field".

Edmund was also one of the investors in the settlement of Southampton, Long Island, NY -- along with Allen Breed, Thomas Newhall and Edmund Needham, among others. In 1640, nine original undertakers were sent by Governor Winthrop to sail from Lynn, Essex co., MA and make the first English settlement in what became Southampton, Long Island, New York. Some claim that he was one of the original 9 undertakers to travel there; however, there is no extant concrete evidence that he actually went there<sup>[11,30]</sup>. They mistakenly landed on Dutch Territory and six of the nine men were briefly detained by the Dutch. Eventually all was sorted out and the settlement on Long Island thrived.

Edmund had initially served in the local militia but on 3 July 1646, he and Robert Mansfield were "freed from common training, keeping their arms complete"<sup>[22,23]</sup>. He was later fined for not training with the militia, but appealed and on 26 December 1648, "Edmund Farrington, on account of age, at his request," was freed from fine for not training<sup>[23,24]</sup>. He was fifty years old at the time.

"Ed. Farington" was owed money -- the amount was not specified -- in the estate inventory of Abraham Belknap of Lynn, Essex co., MA on 16d:12m(February):1643<sup>[9]</sup>.

On 14 November 1648, Edmund & Joseph Armitage stood as sureties for the good behavior of Thomas Beale, who was fined for abusing the Lynn watch<sup>[10]</sup>. On 15 November 1648, Edmund Farrington and other Lynn men were fined for failing to fence their share of the common field against "great cattle"<sup>[11,12]</sup>.

On 27 March 1649, Edmund Farrington sued William Flint for "taking away hay"<sup>[13]</sup>; the case was reviewed on 25 September 1649<sup>[14]</sup>, and was heard again on 26 March 1650, at which time the judgement was reversed<sup>[15]</sup>. In September 1650, Edmund was still having trouble with hay, suing William Flint again<sup>[16]</sup>; this case was reviewed in March 1651<sup>[11,17]</sup>.

On 28 June 1649, as a result of ill-advised words, Edmund was called to account for stating that he wished Major Endicott to hear his son Mathew's court case against Goodman Edwards, because "he had given him apple trees." Edmund was required to publicly apologize for implying that he had bribed Endicott<sup>[11,18]</sup>.

On 29 June 1653, Edward Kemp and Edmund Farrington were presented at court for being drunk<sup>[11,19]</sup>.

On 4 July 1653, "Edmond Farrington" sold to Joseph Pope and Samuel Eborne "two hundred acres of upland & meadow within the bound of Lin and two acres of meadow lying in the Great Meadow about half a mile from the 200 acres"<sup>[23,26]</sup>.

Edmund served on the Essex County Grand Jury on 28 November 1654 and 26 June 1655<sup>[23,29]</sup>. That same year, Edmund built a corn mill on Water Hill -- the watercourse dug for this was called "Farrington's Canal".

On 22 May 1666, "Edmond Farrington of Linn..., yeoman," deeded to "my son Mathew Farrington the one-half of my cornmill with the utensils thereto belonging, with all the profits, produce & effects arising therefrom, except the toll of my son Fuller's grist, which is well & duly to be ground toll free during the life of my daughter Elizabeth his wife. I do likewise five to my son Mathew Farrington the one-half of the mill house, houses, barn & half the upland & meadow that I bought of Nicholas Browne, & half my salt marsh in the Town Marsh," in return for which Mathew Farrington will maintain his father and mother for the rest of their lives, and pay to "my son John Fuller, his heirs or assigns, the sum of ten pounds sterling at my decease."<sup>[23,27]</sup>

On 3 December 1669, "Edmond Farrington of Linn..., yeoman," deeded to "Mathew Farrington of the same Linn...the one-half of all & singular my tide mill at Linn aforesaid, with the housen, barn & several parcels of land thereto belonging"<sup>[23,28]</sup>.

Edmund's will was written on 12 August 1667, proved in Ipswich Court on 28 March 1671 by Nathaniel Kertland, Sr., inventoried on 25d:1m(March): 1671 and attested to in Ipswich Court on 28 March 1671 by Mathew Farrington<sup>[20]</sup>.

### The Last will and Testiment of Edmond ffarrington this 12 of august 1667.

*I Emond ffarrington Being being sike of Body But of perfect memory Impr I bequeth my body to the Earth and my Soull to god who gaue it And my Estat in this world as followeth Imp. I giue to my wiff Elizabeth my half of my land and Corn mill durring Her maturrall liff and to my Son Mathue ||ffarrington|| After Her deseas Itt I giue all my moueables to my wiffe Ir I giue my Sone Edward ffarrington Twenty shillings to be paye ||him|| after my deceas Itt I giu to my Sone Roberd terry twenty shillings to be payd ||him|| After my deceas Itt I giu to my daughter Elizabeth fuller ten pounds to be payd her affter my deceas I make my Sone Mathuw ffarrington my Exce||qu||tor of this my last will and testyment to wich I sett my hand thes day and year abou written.*

*Edmond (his **E** mark) ffarrington.*

*Witness: Nathanill Kirtland, John (his **X** mark) wit.*

Inventory was presented on 25d:1m(March):1671 by "Elezabeth. the wife of Edmond ffarrington, and Mathre ffarrington, his son, taken by Joseph Armitage and Thomas Newhall". It is a surprisingly thin estate for one so rich & influential during his lifetime:

*his wareinge aparill, 5li. 5s.;*

*in bedinge and linene, 12li. 10s.;*

*in brase and puetor, 4li. 16s.;*

*in lumber, 2li. 5s. 6d.*

*total, 24li. 16s. 6[d]."*

On 29 November 1613 when Edmund was 25, he married **Elizabeth NEWHALL**, daughter of [not known] **NEWHALL**, in Sherington, Buckinghamshire, England<sup>[2,31,32,33,34,35,36]</sup>. Her name is given as "Nuall" in their marriage records.

#### Family of Edmund FARRINGTON (1) & Elizabeth NEWHALL

**2. Edward FARRINGTON** (*Edmond*<sup>1</sup>) was born circa 1615 in Olney, Buckinghamshire, England<sup>[31]</sup>. He remained in England. Edward married **Dorothy BROWNE**, daughter of **Thomas BROWNE**.

**3. Thomas FARRINGTON** (*Edmond*<sup>1</sup>) was born circa 1617 in Olney, Buckinghamshire, England<sup>[31]</sup> and also remained in England. He signed the 1640 agreement to settle Southampton and, along with his brother Edward Farrington owed money to the town of Southampton on 6 March 1644/5<sup>[38]</sup>. Thomas married **Helena APPLGATE**, daughter of **Thomas APPLGATE**.

**4. Sarah FARRINGTON** (*Edmond*<sup>1</sup>) was born in 1619 in Olney, Buckinghamshire, England and baptized in Sherrington, Buckinghamshire, England on 5 September 1619<sup>[31]</sup>. She was called variously Sarah and Sarra in records. Sarah migrated with the family in 1635 at the age of 14 and married **Robert TERRY**.

**5. Mathew<sup>2</sup> FARRINGTON, Sr.** (*Edmond*<sup>1</sup>) was born in 1620/1 in Sherrington, Buckinghamshire, England and was baptized there on 12 February 1620/1<sup>[31]</sup>. Mathew's baptism record reads: "Mathyas Farryngton the sonne of Edwarde Farrington baptized the 12th of February 1620/1". He died in January 1700/1; when he was 80 and was buried before 20 January 1700/1 in Lynn, Essex co., MA. Mathew's given name is also spelled Matthew, Mathias and Mathyas in various records.

Mathew migrated to New England with his parents, brother and two sisters aboard the *Hopewell* in 1635. After the death of his father, he became the owner of the "well known tidemill in Lynn"<sup>[5]</sup>. He became a trusted member of the Lynn, Essex co., MA community. Mathew, along with John Fuller, Thomas Couldum, Nathaniel Kirtland and Jonathan Hudson, witnessed Anthony Newhall's will on 14 January 1656. Mathew and John Fuller proved it in court on 31 March 1657. On that same day, Richard Hood was granted administration on the will and Mathew, John Fuller & Nathaniel Kirtland were appointed overseers<sup>[39]</sup>. In addition, Mathew, John Burrill and Nathaniel Kirtland, Sr. were appointed overseers of John Witt, Sr. of Lynn's will of 12 September 1675<sup>[40]</sup>. Mathew's own will was proved on 20 January 1700/1.

In 1648 when Mathew was 28, he married **Elizabeth SISLEY**, daughter of **Henry SISLEY**, in Lynn, Essex co., MA<sup>[2,41]</sup>. Elizabeth died on 15d:10m(December)1678 in Lynn, Essex co., MA<sup>[42]</sup>.

**6. Joseph FARRINGTON** (*Edmond*<sup>1</sup>) was born before 1621 in Olney, Buckinghamshire, England. Anderson, et. al. do not acknowledge this child. Those that do acknowledge this child believe that he stayed in England.

7. **John FARRINGTON** (*Edmond<sup>d</sup>*) was born in 1622 in Olney, Buckinghamshire, England and baptized there on 15 [month illegible] 1622<sup>[31]</sup>. John died in Lynn, Essex co., MA on 2 May 1666; he was 44<sup>[42]</sup>.

John's son Edmund (born 1662) of Andover, Essex co., MA had two indictments brought against him for witchcraft in the Salem Witch Trials. One "for Covenanting w'th the Devill Billa" and one for "Afflicting Mary Warren"<sup>[43]</sup>.

**8. Martha FARRINGTON** (*Edmond*<sup>1</sup>) was born in 1623 in Olney, Buckinghamshire, England. Anderson, et. al. do not acknowledge this child and there is no record of her coming to America. This indicates that she probably either did not exist or died before 1635 when the rest of the family emigrated to New England. The latter is possible, the man who would have been her brother, Mathew Farrington, Jr., named one of his daughters "Martha".

**9. Elizabeth FARRINGTON** (*Edmond*<sup>1</sup>) was born in 1624 in Olney, Buckinghamshire, England. Elizabeth was baptized in Olney, Buckinghamshire, England on 19 September 1624<sup>[11]</sup> and married **John FULLER**.

#### Family of Mathew FARRINGTON Sr. (5) & Elizabeth SISLEY

**10. Mathew**<sup>3</sup> **FARRINGTON, Jr.** (*Mathew*<sup>2</sup>, *Edmond*<sup>1</sup>) was born in 1649/50 in Lynn, Essex co., MA and died in Lynn, Essex co., MA on 16 July 1727; he was 78<sup>[44]</sup>.

Mathew, Jr. took the Oath of Freeman on 18 April 1691, most likely in Lynn, Essex co., MA<sup>[46]</sup>. On 7 July 1682, Richard & Mary deeded over to Matthew Farrington, Jr. "...a dwelling house and all that parcell of land sometime in the possession of Anthony Newhall deceased, viz., four acres more or less, or two-thirds of a six acre lot where the house stood, bounded Westerly with land of John Gillow, Easterly with land of John Hawthorne, Northerly with land of Robert Potter, Senr, Southerly with the country highway that lyeth in the mill street..." This four acre lot had been bequeathed to Mary in her father, Anthony's will<sup>[45]</sup>.

On 28 April 1675 when Mathew was 26, he first married **Sarah POTTER**, in Lynn, Essex co., MA<sup>[2,47,48,49]</sup>. Sarah died in September of 1687 in Lynn, Essex co., MA and was buried on 14 September 1687 in the Old or Western Burial Ground in Lynn, Essex co., MA.

Before 1689 when Mathew was 40, he second married **Mary NEWHALL**, in Flushing, Long Island, NY<sup>[2,50]</sup>. Mary was born in 1669 in Lynn, Essex co., MA and died in Lynn, Essex co., MA as "Farinton, Mary, wid..in her 86th year" on 12 May 1755; she was 86<sup>[51]</sup>. Mary was buried on 14 May 1755 in Lynn, Essex co., MA as "Farrington, \_\_, 'Old Granne'"<sup>[52]</sup>.

**11. Sarah1 FARRINGTON** (*Mathew*<sup>2</sup>, *Edmond*<sup>1</sup>) was born on 13d:12m(February):1657 in Lynn, Essex co., MA as "Sara, d. Farrington, Mathias"<sup>[53]</sup> and died in Lynn, Essex co., MA on 6d:4m(June):1659; she was 2<sup>[54]</sup>.

**12. William FARRINGTON** (*Mathew<sup>2</sup>, Edmond<sup>1</sup>*) was born on 6d:3m(May):1660 in Lynn, Essex co., MA as “s. Mathias”<sup>[55]</sup>.

**13. Sarah<sup>2</sup> FARRINGTON** (*Mathew<sup>2</sup>, Edmond<sup>1</sup>*) was born on 15d:4m(June):1663 in Lynn, Essex co., MA as “Sara, D. Matthias”<sup>[2,56]</sup>. Torrey says that she was born in 1664. Sarah<sup>2</sup> died in Lynn, Essex co., MA on 2 April 1752 As “wid. Ens. Joseph..a. 88y. 10 m. 17 d.”<sup>[2,57]</sup>. Sarah is buried in the Old or West Cemetery in Lynn, Essex co., MA.

On 27 September 1683 when Sarah<sup>2</sup> was 20, she married **Ensign Joseph BREED**, son of **Allen BREED & Mary SARGENT**, in Lynn, Essex co., MA<sup>[2,58,59,60,61,62,63,64]</sup>. Their marriage record reads “Bread, Joseph and Sarah Farrington”.

**14. Theophilus FARRINGTON** (*Mathew<sup>2</sup>, Edmond<sup>1</sup>*) was born on 13d:6m(August):1666 in Lynn, Essex co., MA as “s. Mathew”<sup>[70]</sup>.

**15. [probably John] FARRINGTON.** (*Mathew<sup>2</sup>, Edmond<sup>1</sup>*) John’s parentage as being the son of Mathew and Elizabeth [Sisley] Farrington is not strictly proven, but signs point to it in the accepted genealogies of Farrington and Newhall<sup>[5]</sup>. He married **Lydia HUDSON** and they had one child:

**16. Sarah<sup>1</sup> FARRINGTON** (*Mathew<sup>3-2</sup>, Edmond<sup>1</sup>*) was born in “the beginning of” February 1675 in Lynn, Essex co., MA<sup>[70]</sup>. This year must be 1676, and not 1675. She died in Lynn, Essex co., MA on 26 November 1676; she was 1<sup>[71]</sup>.

**17. Sarah<sup>2</sup> FARRINGTON** (*Mathew<sup>3-2</sup>, Edmond<sup>1</sup>*) was born on 20 September 1677 in Lynn, Essex co., MA as “Sarah, second”<sup>[70]</sup>.

**18. Martha<sup>4</sup> FARRINGTON** (*Mathew<sup>3-2</sup>, Edmond<sup>1</sup>*) was born on 2 May 1679 in Lynn, Essex co., MA<sup>[70]</sup>. Her birth date is given as 12 July 1679 in the Lynn, Essex co., MA vital records and 2 May 1679 in the Court Record. Martha died in Lynn, Essex co., MA on 9 August 1760; she was 81<sup>[72]</sup>. She is buried in the Old or Western Burial Ground in Lynn, Essex co., MA.

On 13 October 1702 when Martha was 23, she married **The Honorable Ebenezer BURRILL Esq.**, son of **Lieutenant John<sup>2</sup> BURRILL & Lois IVORY**, in Lynn, Essex co., MA<sup>[73]</sup>.
