**2.** Mary HILLS (Joseph¹) was born circa 1625<sup>[1]</sup>. Mary died in Malden, Middlesex co., MA on 25d:9m(November):1674; she was 49<sup>[1,2,3]</sup>. She must have migrated to New England, but we do not know when or on what boat.

Before 1650 when Mary was 25, she married **Captain John WAITE**, son of **Samuel WAITE** & **Mary WARD**, in Charlestown, Suffolk co., MA or Malden, Middlesex co., MA<sup>[1,4,5,6,7,8,9,10,11,12,13,14,15,16,17]</sup>.
