#### **First Generation**

**1. Christopher [Christian] LINDSEY** was born circa 1617 in Stepney, Middlesex, England and died in Lynn, Essex co., MA on 10 April 1669 as "Linsy, Christopher"; he was  $52^{[1,2]}$ . We are currently unsure of his emigration information. Once here, he settled in Lynn, Essex co., MA, most likely following his master, Thomas Dexter, to the area. After obtaining his freedom from servitude to Dexter, Lindsey became a carpenter and settled on the northeastern part of Nahant, Essex co., MA known as "Lindsey's Hill" -- which was named for him.

Christopher served in the Pequot War. He was wounded and disabled from service for 20 weeks, for which he was awarded a pension on 23 May 1655. In 1658, Christopher testified for Thomas Dexter in his suit over the ownership of Nahant. Dexter was a wheeler-dealer and quite a character and claimed that he owned the peninsula of Nahant, having bought it from one of the natives for a suit of clothes. He thankfully lost both suits (pun quite intended).

"Estate of Christopher Lyndsey of Lynn.

The Last will, & testimony of christipher Lynsye of Lynn in the Countye of Essex being weake of bodye but of good memorye & vnderstanding: April:9th:1669 Impr: I bequeath my bodye to the earth, & my "Spiritt to him yt gave it mee: 2ly I bequeath to my Son Eliezer my Eldest horse: & 3 gotes & 2 swine: 1 begger & one Lesser: 3ly I bequeath to my Son John my mare & 3 gotes: & 1 biger swine 4lye I bequeath to my daughter Nahomie, my yonger horse, & my Heifer, & 3 sheep: & seaven gotes: & ye other 2 swine: It: I bequeath all my tooles equally to bee devided betwixt my two sons It: I bequeath to my daughter Nahomie all my bedding & Lining & all my potts & kettles & puter & my house, & Land: It: I bequeath to my 3: children all yt is oweing mee onelye my daughter shall haue a quarter more then ether of my sonns: It: I bequeath to my daughter all my pvisions & all the rest of my goods:"

Christopher (his J Mark) Lynsye.

Witness: Joseph Reddknap, Andrew Mansfeild.

"This 10th:April:1669 Memorandum: this is my minde & will that the charge of my burial shall be discharged equallye out of the Legasyes aboue said: Alsoe I make my sonn Eliezer my executor: & hee is to bee paid for all his trouble, & expenses, out of the Legasyes of his brother John & his sister Nahomie pportionablye & one pound more Alsoe I desyre William Bassitt, & Andrew Mansfeild to bee overseers of this my will." Christopher (his J Mark) Lynsye.

Witness: Joseph Reddknap, Andrew Mansfeild, William Bassett Proved in Salem court 29:4:1669 by the witnesses.

Will of Christopher Linsy was proved and an agreement in writing by the three children about the division of the estate among themselves was allowed and ordered to be recorded. An inventory of the estate presented by his son Eleazer, was also allowed. Salem Quarterly Court Records, vol. 5, leaf 23.

Inventory of the estate of Christopher Lynsye of Lynn, deceased April 10, 1669, taken April 12, 1669, by Joseph Redknap, Andrew Mansfeild and William Bassett:

Agreement, dated 19:2:1669 among the children John, Eleazer and Nahomy Lynsey that the whole estate of their father should be divided equally. Witness Joseph Armitage and Sarah Lynsey. Essex County Quarterly Court Files, vol. 14, leaves 123, 124."<sup>3</sup>

Circa 1644 when Christopher was 27, he married **Margaret [surname not known]**, in Lynn, Essex co., MA<sup>[4,5,6]</sup>. Margaret died as "Linsey, Margrett, w. Christopher". on 30d:10m:1668 in Lynn, Essex co., MA<sup>[1]</sup>.

**2. Coronet Eleazer<sup>2</sup> LINDSEY** (*Christopher*<sup>1</sup>) was born circa 1644 in Lynn, Essex co., MA and died in Lynn, Essex co., MA on 20 May 1716 as "Lindsey, Eleazur, sr." aged 72 years.; he was 72<sup>[7]</sup>.

Eleazer was a House-carpenter The house he built for his family was destroyed in June 1893<sup>[8]</sup>. He took the Oath of Freeman on 18 April 1691<sup>[9]</sup> and the Oath of Fidelity to Country on 27 February 1677, and the Oath of Allegiance to the King in 1678. As seen by his title of "Coronet", Eleazer served in the Lynn militia. He was in King Phillips' War and was paid £1 16s. 0d. for his service on 24 August 1676.

In August 1668 when Eleazer was 24, he married **Sara ALLEY**, daughter of **Hugh ALLEY** & **Mary GRAVES**, in Lynn, Essex co.. MA[4,8,10,11,12,13,14,15,16]

As such, finding the vital records of them and their children are more difficult. They registered them with the Quaker church rather than the town government. This is not to say that all Quakers shunned the colonial town structure. But Samuel was an ardent convert to the religion and he and Abigail were the patriarch and matriarch of the Quaker branch of the Newhall family. Given that he came of age during the 1692 Salem Witch Hysteria and converted to the religion at a time of great persecution of the Quakers by the prevailing Puritans, it is not a great leap to assume that he preferred to protect himself and his family with as little contact with Lynn as possible.

On 31 December 1695 when Abigail was 18, she married **Samuel NEWHALL**<sup>[26,27]</sup>, son of **Thomas NEWHALL** & **Elizabeth POTTER**, in Lynn, Essex co., MA<sup>[4,8,28,29,30,31,32,33]</sup>. An intention was also filed in Lynn, Essex co., MA on 31 December 1695 as "Samuel Newhall & Abigail Lindsey, both of Lynn.". Joseph's son, Hanson, and Huldah's daughter, Hepzibah, married.
