Surname variations include: Wilson, Willson, Wollson, Woolson and Wilcon.

First Generation

1. Robert WILSON is currently a frustrating dead-end. He is called "of Sudbury", Middlesex co., MA on his marriage record^[6], but I have not been able to find his birth and parentage information. Based on his estimated marriage date of 1666, he was probably born around 1640-1645. He died sometime before 1688, when his wife remarried.

Before 1666 Robert first married, **Deborah STEVENSON**, daughter of **Andrew STEVENSON** and **Jane[surname not known]** in Cambridge, Middlesex co., MA^[2,3,4,5].

2. Andrew² WILSON (*Robert¹*) was born on 17 April 1670 in Cambridge, Middlesex co., MA^[2,7] and died in 1722; he was 51^[2]. Andrew was taxed in Charlestown, Suffolk co., MA from 1727-1756, excluding 1734 and 1739, with taxes abated there in 1736-7^[8].

Before 1696 when Andrew was 25, he married **Hannah WILLIAMS**, daughter of **Thomas WILLIAMS & Mary HOLDEN**, in Cambridge, Middlesex co., MA^[2,9,10,11,12].
